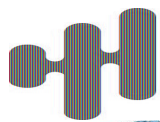
ICV Certification Services

Yasser A. Haikal Auditing and Accounting has been appointed as ICV Certifier for ICV Program Implementation by Tawteen and QP

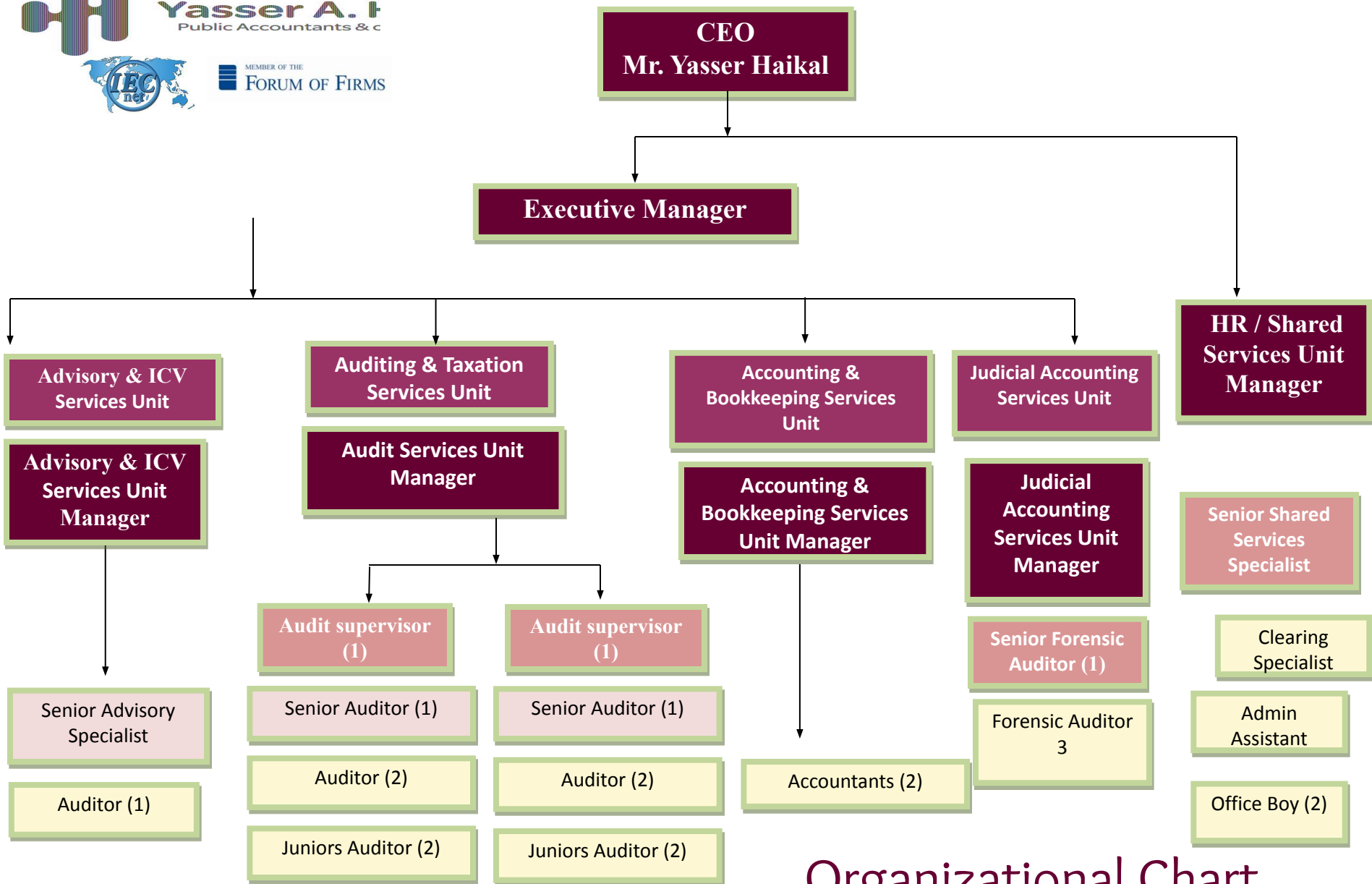

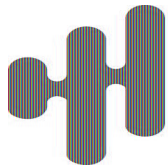

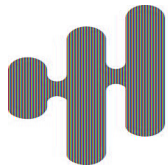
Organizational Chart
